## The Programme Admission Requirements

The admission requirements for the Doctoral Programme in Art Studies (History of Art) are follows:

- a) Master's degree or equivalent academic degree in Art Studies, Arts, Education, Law, Natural Sciences, Social, Humanities and Interdisciplinary Sciences.
- b) The exam in English language B2 level. A person, who presents a higher education diploma with the relevant foreign language specialty, or a certificate proving the pass of an examination in an accredited higher education institution of the relevant profile (not less than B2 level) or an internationally recognized certificate of a foreign language proficiency (TOEFL PBT, TOEFL IBT, IELTS or Cambridge Exam) is exempted from the foreign language test. In certain cases, based on research specifics, the University reserves the right to require knowledge of the additional foreign language.
- c) An applicant for the Doctoral Programme is required to submit a relevant field research paper (minor research/publication/Master's thesis, etc.), if any; Also, an applicant should receive a consultation by the Programme Director/Possible Scientific Supervisor and submit their written consent on compliance of his/her research interests with the programme.
- d) An interview in the specialty (art history) for which the applicant is required to summarize the relevant scientific project summary, according to his/her scientific interests.

Work experience is not mandatory. The rule for enrolling, learning and awarding academic degree in the University Doctoral Studies are determined by the normative acts of Georgia, the University Statute and the Rector's individual-legal acts. It's possible to receive 5-6 doctoral students on average.

## The Programme Purpose

The present Doctoral Programme aims to prepare highly qualified art experts-researchers in the field of art history and theory relevant with the requirements of modern international standards, who can independently conduct scientific studies and teach in higher education institutions. The programme has a specific purpose: to conduct studies in the field of Georgian art of Medieval times, based on Georgian material, raise problems, unstudied issues, and review them in different contexts. The Programme aims to prepare an expert of art studies (art historian), who possesses the appropriate knowledge and research methods in the field of art history; has the ability to conduct research independently, deeply understand existing ideas and approach them critically, analyze new materials, make logical conclusions and create new knowledge in the field of art history, which will have not only local significance, but also contribute to the development of art sciences.

The Programme aims to pay particular attention to the study of the national medieval historical processes, its understanding in the international context and the creation of new knowledge in the field through the dissertation work. Taking into consideration the situation in the field, there is a particular deficit of young researchers in the field of medieval Georgian art - manuscript book painting, Georgian goldsmithing. However, the mentioned fields have left a large number of cultural heritage monuments, which are unexplored and waiting for their researchers. One of the tasks of the present programme is to encourage and support doctoral students in research in this field, which is guaranteed by the academic and invited staff involved in the programme. The history of Georgian art demonstrates the transition of firm artistic forms through centuries, which consolidates the Georgian art of all times and epochs and defines its place in the world culture. Development of the Doctoral Programme will promote the deep awareness, protection, and preservation of the national-cultural identity of Georgia and its full demonstration. Based on the above mentioned, the significance of preparation of the art scholars in the University framework is evident. The Doctoral Programme in the history of art, together with the general culture, has an essential significance in terms of national identity. In this context as well, purposeful studies of our cultural heritage respond to the challenges of modern times.

The Content and Structure of the Programme

The content and structure of the programme is determined by the balance of learning and scientific components. The sequence of components of the programme is logically related to each other: In the first semester the programme is more loaded with learning component, scientific part increases in the next semester, which also implies the possibility of consistent production of the research and is constructed on the logical connection between the components; All the above mentioned is reflected in the attached scheme of the programme according to the semester.

The learning component related to the research field includes essential seminars and learning courses, which serve, on one hand, to deepen the field of study, through a thorough study of existing research, on the other hand, to master modern methods of research and teaching, accumulate scientific-pedagogical experience. Apart from the mandatory courses and seminars, the block of existing elective courses gives a doctoral student an opportunity to compile his/her individual plan, according to the interest.

Scientific component, research topics and tasks are defined. The research topic may be selected through the learning of different fields of art (architecture, relief, painting, goldsmithing), the dissertation theme may be limited to either specific field or certain monuments, as well as any scientific problem, which implies research of different fields and requires interdisciplinary approach, determining the diversity of the connection of different fields within one culture. Other research topics can be: a specific monument or a group of monuments that have not yet been studied; issues of transformation and influence of Byzantine, Islamic, European, etc. artistic tendencies that came to Georgia, impact of Georgian art on other countries and cultural communities. In addition to the above mentioned essential issues, a doctoral student will have the opportunity to study and research other specific issues related to the history of art.

The research methodology is mainly determined by a comparative, artistic analytical method, but the methodology of each particular topic will be individually chosen, based on the research problem. The Doctoral Programme envisages interdisciplinary researches as well with the possibility of involving researchers of the relevant fields as consultant/co-supervisor. However, the subject of the separate research may become the methodology and historiography of art studies itself.

One of the essential tasks of the programme is to create for doctoral students such conditions to thoroughly understand and master the core ideas of the art history and field, thus we will maintain continuity and vitality in the field of art studies; The next task to accomplish the goals set by the programme is understanding by the future PhD how the field of art studies is displayed in the common intellectual space. The process of learning and research in Doctoral studies should also be directed to the development of cooperation skills: a PhD should know how to cooperate with the specialists of the related humanities, social and other interdisciplinary fields in the process of research.

The next task of the programme is to develop in a doctoral student an ability to transform knowledge. He/she should be able to present the material in understandable form, transfer the knowledge, and teach. He/she should be able to transfer knowledge to all interested persons at any

level (professional community, wide society).

The importance and significance of the programme is conditioned by its purpose - promote the research of such issues, which will show the Georgian art, as the part of the world art, which shows its diversity of connections-relations with other peoples art. The processes of the history of Georgian art will be discussed in relation to the world artistic events in the international context. In this way the programme will create new knowledge in the field of art history.

Therefore, the content of the programme responds to its purpose - to conduct fundamental research, which will contribute to the scientific, social, economic, cultural and other development at regional, national and/or international levels. The staff prepared on the basis of the programme will contribute to the protection and development of national culture, as well as research of world cultural values and works of art; will promote new artistic values, innovations and integration into society.

## Teaching and learning methods

An academic methodology of the Doctoral Programme considers the application of different methods of teaching. The priority is given to an intensive teaching - colloquiums and practice-assistantship. While teaching, when necessary, it is possible to merge methods. It especially concerns the inductive and deductive methods of teaching, the synthesis of which may be conducted within the frames of a certain discipline. In the process of teaching, under the supervision of the teacher, the colloquium topic and task determined by the syllabus may be developed both towards the generalization of certain facts as well as towards the initial identification of general characteristics and learning of further findings. A deductive method is especially acceptable in case of the colloquium, when a doctoral student acquires new, in-depth knowledge in a particular direction on the basis of general knowledge already acquired by him/her.

In case of having a few doctoral students, the method of working in teams will be also applied. Working on joint tasks, redistribution of functions, will develop the doctoral students' skills of working in teams.

From other teaching methods, analysis and explanatory methods are used. Among the above-mentioned, the analysis method is used for solving particular tasks, whereas the explanatory method implies thinking around the issue at seminars, a detailed review of a particular example within the frames of a given topic.

A special significance is paid to action-oriented teaching in the methodology of teaching, the share of which mainly rests on the process of

assistantship. Student is given an opportunity to apply the theoretical knowledge in practice. Assistantship develops the necessary skills: skills of relationship with the student, transforming the knowledge, presenting the material, transfer of knowledge, etc.

The learning process, which is divided into semesters, also considers the necessary work for the scientific research starting from the first semester: After every semester, it is required to present a research of a particular issue or material reflecting a particular stage of the research paper. The methodology of the research itself will be selected based on the certain research topic. The teaching/learning methods used in the process of the teaching course of the programme are indicated in the syllabus of each course.

Completion of the full course of the Doctoral Programme and the thesis defense will have the following results:

- We will have the work, which will be a new research and will bring new knowledge into art studies;
- · A doctoral student will obtain an academic degree Doctor of Art Studies.

#### The Doctoral Programme graduate has the following field competencies:

- A doctoral programme graduate will have a thorough, profound and systematic knowledge based on recent achievements in the history of art, global vision of future research problems;
- He/she will have the ability to research and analyze historical processes in art;
- He/she will deeply understand the essence of the art, the importance of cultural heritage and will be able to find the appropriate ways and methods to transmit the knowledge.
- A doctoral programme graduate will be able to make sense of Georgian art in the context of world Art, to perceive the essence of cultural diversity and difference, to establish relationships between the arts of different peoples. He/she will be able to discuss them, in terms of common historical and cultural context, and if necessary, interdisciplinary analysis will be used.
- Theory of art and scientific research methods will enable a doctoral student to work at the level of international standards; the doctoral student chooses the methodology and provides dating of unstudied artwork as well as an assessment of the artistic and historic places.
- · The Doctor of Art Studies will be able to apply the knowledge in practice, on one hand, to transmit the knowledge of art history and theory to

students studying at various educational levels and on the other hand, to approach to the problem analytically in the process of scientific research, to plan and implement research project independently, as well as supervise the research process; Based on the mentioned factors, he/she will be able to create new knowledge, which will be reflected in his/her scientific publications.

- A doctoral programme graduate will be able to conduct a multilateral study of a monument of art or group of monuments of art; If necessary, he/she will be able to provide reasonable dating, considering a common historical context and giving a place in the history of art. A doctoral programme graduate can perform qualified expertise on visual art work or museum collection.
- He/she will have the ability to make a reasoned conclusion even if the data is complex, incomplete and contradictory. In this process a doctoral programme graduate will be able to use new approaches, additional resources (if necessary), and take the right and effective decision independently.
- With adequate knowledge and research skills of art history and its specific field, the graduate will be able to evaluate and criticize the existing information, as well as to follow the acquired knowledge and logically substantiate conclusions. All the above-mentioned will prepare a specialist, having the ability to conduct research independently and develop future projects.
- The Doctor of Art will be able to fully consider and understand the existing knowledge and basic ideas in the field of art history. By this we will maintain the continuity of knowledge in the field of art study; By doing so, a doctoral programme graduate will be a bearer and keeper of knowledge and experience in the field of art study.
- The Doctor of Art Studies will learn how his/her scientific research field is placed in the common intellectual space; will learn how to cooperate with the specialists of related fields in the process of interdisciplinary research.
- A doctoral programme graduate should be able to bring up the next generation; a doctoral programme graduate will have the ability to transform knowledge. He/she should be able to present the material in understandable form, transfer the knowledge, and teach. He/she should be able to reveal knowledge to all interested persons at any level (professional communities, wide society).

#### The Doctoral Programme graduate has the following general competencies:

#### a) Knowledge

The graduate of the Doctoral Programme has developed scientific-research skills, qualifications and competencies, which enable him/her to conduct scientific-research work independently, to lead lecture courses in the chosen specialty and with a wide range of aspects. The programme graduate has a broad and profound education, professional knowledge of the world and national arts; Has the ability to implement acquired knowledge in practice, to analyze critically, approach the problem, to process and analyze scientific information; Ability to distribute publications and apply the knowledge in practice.

- The Doctoral student has a high-qualified knowledge of the history of art, broad and profound knowledge of the principles and methodology of

world art.

- The Doctoral student has a broad and profound knowledge on the specifics of the field; possesses knowledge of the peculiarities of its assessment criteria; understands his/her own responsibility to broaden the acquired knowledge based on the correctly chosen methodology.
- The Doctoral student understands the importance of expressing the peculiarities of the artistic creativity for a complex study of historical and modern work aspects, which is related to popularization and development of culture.
- The Doctor of Art Studies has profound knowledge of the theoretical and research methodologies in the field; Possesses basic and contemporary theoretical concepts; is able to operate with new scientific-terminology, which allows to reevaluate the part of existing knowledge with international standards and new perspectives; is able to develop a new research-analytical approach, which is oriented on new knowledge; Recognizes the place of research subject in the modern knowledge system and its relationship with other sciences of the humanities.
- The graduate has the ability to draft scientific texts, through formatting by modern scientific standards and academic argumentation; Possesses the ability to conduct teaching process using educational technologies, methodological fundamentals of teaching in higher education; Acknowledges his/her goals and outcomes.

## b) Skills:

- The Doctoral student can conduct highly qualified researches based on the analysis of the main trends-directions of the world and the Georgian art, thus, creating new knowledge in the field;
- Can prepare scientific publications of the modern standard in the field of art history;
- Has the ability to supervise or participate in the planning of museum tourism; in the organization and implementation of presentations of media projects, exhibitions-expository, presentations of various character.
- A doctoral student will use the obtained knowledge along with the methodology of art studies in leading the academic process independently based on the relevant methodology.
- A doctoral student has the ability to develop solutions to complex problems, new research-analytic approaches, which are oriented on formation process of new knowledge; to create publications with high research value products and to successfully implement them in practical work while working at scientific institutions and universities.
- A doctoral student has the ability to implement scientific operations and build successful partnerships with scientific communities of adjacent fields.
- A graduate is able to prepare teaching-methodological materials for the field of art studies using his/her qualification; to evaluate scientific work

and present the research results in front of various types of auditorium successfully.

- A doctoral student has the skills of implementing modern standards of teaching in practice; skills to implement cultural-educational and teaching-educational programmes/projects.
- The graduate is able to critically analyze, synthesize and evaluate new, complex and conflicting ideas and approaches in the field of art history; can select the appropriate method/methods of problem solving and also, if necessary, develop a new methodology independently; Make the right and effective decision to solve the problem independently;
- A graduate of the educational programme has the ability to make professional conclusions based on analysis and evaluation in the process of solving specific issues and problems of the field.
- A doctoral student is able to find ways of an efficient and objective approach to solving problems of the field; he/she has the ability to critically analyze, synthesize and evaluate contradictory historical or new ideas.
- He/she has the ability to work in the interdisciplinary groups;
- He/she has the ability to be involved in thematic debates with local and international scientific community in both native and foreign languages.
- He/she has the ability to conduct scientific work, to elaborate and manage projects.
- He/she has the ability to develop exhibition and educational projects in art studies, taking into consideration the interests of representatives of scientific and cultural fields.

## Responsibility and Autonomy

The possibilities for the use of new ideas, scientific achievements, in the process of study and research, which is based on the knowledge obtained under the programme. The knowledge based on the latest achievements in the field of Art History, the readiness to develop new ideas or processes in the learning and activities, including the research process.

A graduate is able to objectively assess his/her own and colleagues' attitudes towards professional and scientific values. He/she can make a significant contribution to establishing cultural heritage as a value in the society. He/she can research the ways of establishing cultural heritage as the value and develop innovative methods of establishment.

The aim of the evaluation of student's knowledge, achieved progress, is to qualitatively determine his/her learning outcomes with regard to educational goals and parameters.

Within module/learning course, the structure of assessment is divided into two elements, such as midterm assessment and final assessment. Each has its percentage share in the assessment system.

The midterm element of the evaluation can be divided into components (activity, midterm exam, presentation of an abstract, practical work, review about the other person's work (including the other doctoral students work), etc.) which also have their percentage share within this element. Taking into account the relevant percentage share, each concrete assessment is based on the results of the sum of both elements.

The format of the midterm assessment, as well as the final exam (written, oral), development of research work, presentation of the research paper, assessment components and their specific share are determined by the leading staff of the academic course, through the learning course (syllabus).

According to the scale of the European Credit Transfer and Accumulation System (ECTS), a credit - a unit is used for evaluation of students' knowledge. It expresses the volume of work performed by the student to complete one subject, reflected in the time unit - in hours.

Credits can be obtained only after achievement of learning outcomes by the student as planned according to the learning course (syllabus), which is reflected by one of the positive assessments provided by the established assessment system.

It is unacceptable to evaluate the learning outcomes achieved by a student on a one-time basis - only by evaluating the final examination. The evaluation of the student's knowledge by a certain ratio considers midterm and final examination.

The maximum evaluation for the academic course equals to 100 points.

The final examination is evaluated by no more than 40 points. A student, who accumulates minimum 30 points in the midterm evaluations, is allowed to attend the final exam.

The student's knowledge is assessed according to the following system:

- a) Five types of positive evaluation:
- a) (A) Excellent 91% and over of maximum grade;
- b) (B) Very good 81-90% of maximum grade;
- c) (C) Good 71-80% of maximum grade;

- d) (D) Satisfactory 61-70% of maximum grade;
- e) (E) Sufficient 51-60% of maximum grade.
- b) Two types of negative grades:
- b.a) (FX) Did not pass 41%-50% of the maximum grade, meaning that a student requires some more work before passing and with independent work is given the right to retake additional exam once again;
- b.b) (F) Fail 40 and less of maximum point, which means that the work carried out by the student is not enough and he/she has to retake the course.

The Doctoral Programme is considered to be completed by a student, if he/she has accumulated credits provided by the educational programme and successfully defended the dissertation work in accordance of the rule established within the University.

The dissertation work is evaluated by the following principle:

- 1. The evaluation of the dissertation by the members of the Dissertation Commission is performed in a confidential manner, using a 100-point system.
- 2. The Commission elected by the Dissertation Commission for the calculation of the ballots, with the purpose of the final evaluation of the dissertation, calculates the arithmetical mean of the points, which will be compared with the Latin evaluation according to the following scheme:
  - A) Excellent (summa cum laude) excellent work 91% and more of the maximum assessment;
- B) Very good (magna cum laude) result, which exceeds the defined requirements in all aspects 81-90% and more of the maximum assessment;
  - C) Good (cum laude) the result, which exceeds the defined requirements 71-80% of the maximum assessment;
  - D) Medium (bene) a result that meets all the defined requirements in all respects 61-70% of the maximum assessment;
  - E) Satisfactory (rite) the result, that despite its deficiencies, still meets the defined requirements 51-60% of the maximum assessment;
- F) Unsatisfactory (insufficienter) a result that fails to meet the defined requirements due to major deficiencies 41-50% of the maximum assessment;
- G) Completely insufficient result (sub omni canone) that fails to completely meet the requirements set 40% and less of the maximum assessment.

The component assessment criteria are thoroughly reflected in the course syllabi, the scientific component assessment criteria are outlined in the syllabi and in the provisions of the Doctoral Programme and the Dissertation Council. (Provisions of the Doctoral Programme and the

Dissertation Council of St. King Tamar University of Patriarchate of Georgia, Articles 8, 9, 10, 15, 16, 17, 18, 19, 20).

During learning at the Doctoral Programme, a doctoral student is obliged to assist academic staff and participate in the education process of the University.

Assistance to a professor implies the following: conducting group work, laboratory work, internships for Bachelor's and Master's students; preparation of midterm and final exam questions, tests; correction of student theses, review of Bachelor's and Master's theses; supervision of Bachelor's theses; tutoring, assisting in scientific work, etc.

The evaluation of a Doctoral student with regard to assisting to the professor is performed on the basis of a report prepared about the implemented work.

When involving the Doctoral student in academic activities, credits are awarded based on calculation of auditorium hours with students.

In the process of assisting (5 credits), the Doctoral student assists to his/her own scientific supervisor and/or is involved in University's academic or research activities.

Preparing and conducting a demonstration lecture (5 credits) within the Doctoral Programme learning component serves to integrate learning and teaching processes, which aims at connecting academic education and theory with real practice; increasing involvement in the processes, which facilitates the Doctoral student's career through the development of practical skills.

## Areas of Employment

A specialist with the Doctoral Degree in Art Studies will be able to work in higher education and scientific-research institutions, specialized colleges, museums, exhibitions, archives, tourist organizations and media space. As an expert, it is permissible to be employed in state and non-governmental and private structures, he/she is able to work as a free scholar.

Information on the human resources necessary for the implementation of the educational programme

The programme is provided with the academic and invited staff having appropriate qualification. Academic staff and invited specialists of St. King Tamar University of Patriarchate of Georgia, leading researchers in the field and, if necessary, professors of relevant departments of foreign universities participate in the development and implementation of the programme.

The labor agreements with academic staff and invited specialists (teachers) are concluded in accordance of the rules established by the legislation of Georgia.

#### Principle of redistribution of Doctoral Programme Credits

The Doctoral programme implies 180 credits, 50 credits out of which considered to the learning component and 130 credits - to the research component.

The semester plan of the programme implies the considered distribution of learning and scientific work hours: first semesters are loaded with the learning hours and the share of research work increases in each subsequent semester. Accumulating of learning credits are completed in 3 semesters and the remaining 3 semesters are fully dedicated to scientific work.

130 credits of the **scientific work** of the present programme are considered to be mastered and are awarded in total to the doctoral student after the defense of the dissertation.

The doctoral student is obliged to work with the scientific supervisor on systematic basis and submit the information on the performed work at the end of each semester to the Faculty Council, and once in a year make presentation at the Faculty Council (colloquiums). The information about the colloquiums is provided in the provisions of the Doctoral Studies and Dissertation Council. The reports of all semesters, signed by the doctoral student and the supervisor, are kept in his / her personal file.

The presentation **for approval of dissertation topic and title** takes place at the end of 2nd semester, after submission of the Research Project of the Doctoral student at the Faculty Council session and by its decision is then presented to the Dissertation Council.
